A Resolution to Authorize the Sale of Two City Cars

WHEREAS, the Glenarden Police Department in the City of Glenarden government has replaced two aging city vehicles with new vehicles; and

WHEREAS, the City Managers vehicle, a 1998 Ford Taurus (Green), Vehicle Number 2FAFP71W52X156806, is in disrepair; and

WHEREAS, one of the City's police vehicle, a 2000 Ford Crown Victoria (White) Vehicle Number 1FAP52U1WA159279, is in disrepair; and

WHEREAS, Capitol Auto Auction is willing to pay \$500.00 for the Ford Taurus and \$800.00 for the Ford Crown Victoria; and

WHEREAS, Section 828(a) requires the City Council to consent to City property being declared as surplus property

NOW, THEREFORE BE IT RESOLVED; by the City Council of Glenarden, Maryland sitting in Regular Session this 14th day of April 2014 as follow:

1. The attached list of city property be hereby declared surplus property.
2. That the 1998 Ford Taurus (VIN #2FAFP71W52X156806) and the 2000 Ford Crown Victoria (VIN# 1FAP52U1WA159279) be delivered to Capitol Auto Auction.
3. That all revenues collected from the sale of the two city vehicles shall be deposited into the General Fund Line.
4. This resolution shall take effect immediately following the approval by Council.
