WHEREAS, Weyrich, Cronin & Sorra Chartered informed the City Manager and the City Treasurer that additional work would need to performed in order to start the FY13 audit; and

WHEREAS, said additional duties were outside the scope of their engagement letter; and

WHEREAS, Interim City Manager and City Treasurer entered into an agreement with Weyrich, Cronin & Sorra Chartered to perform the additional work for an additional \$2,626.50; and

WHEREAS, the Council has determined that the additional service was needed to close out the city's books for the following years 2009, 2010, 2011, 2012 and 2013 to start the current year audit.

NOW, THEREFORE BE IT RESOLVED; by the City Council of Glenarden, Maryland sitting in Regular Session this 14th day of April 2014 as follows:

1. Payment in the amount of \$2,626.50, per attached invoice, to Weyrich, Cronin Sorra Chartered be and it is hereby authorized.
2. These funds for this expense will come from budget line item 10-45-10-7130.
3. This resolution shall take effect immediately following approval by Council.
