A Resolution to Authorize Purchase of Bronze Plaques for the Veterans' Memorial From The Lucian Company and to Authorize the 50% Payment for Deposit

WHEREAS, the Council has determined that it is in the public interest to authorize the construction of a Veterans' Memorial; and

WHEREAS, the plans for the Veterans' Memorial include a series of bronze plaques that will contain the names of the veterans; and

WHEREAS, the City has received sales estimates from The Lucian Company dated November 26, 2013, a copy of which is attached hereto and marked as Exhibit A, for the purchase of the plaques for a total amount of \$25,911,45, with a required down payment of 50% of the contract price; and

WHEREAS, the Council has determined that it is appropriate to purchase the bronze plaques from The Lucian Company; and

WHEREAS, the Council has determined that it is appropriate to authorize the payment of the 50% deposit, in the amount of \$12,955.72, to The Lucian Company; and

WHEREAS, due to the time of year when the work can be done, the Council has determined that an emergency exists which authorizes an override of the bid process under Section 826 of the City Charter.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of Glenarden, Maryland sitting in Regular Session this 16th day of June, 2014 as follows:

1. That the purchase of the plaques from The Lucian Company for a not to exceed sum of \$25,911.45, per the proposals attached as Exhibit A to this Resolution, be and it is hereby approved; and
2. That the payment of \$12,955.72, to The Lucian Company as a 50% deposit for the bronze plaques for the Veteran's Memorial be and it is hereby approved.
3. Payment for the plaques shall be made from the State bond bills;
4. The Council President shall be and she is hereby authorized to sign a purchase order for the plaques on the terms and conditions set out herein.
5. This Resolution shall take effect immediately upon passage.
