**A Resolution to Re-Authorize the Sale of One City Car**

**WHEREAS**, Resolution R-37-2014 declared a 2000 Ford Crown Victoria (White) Vehicle Number 1FAP52U1WA159279 owned by the City as surplus property and authorized its sale to Capitol Auto Auction for the sum of \$800.00; and

**WHEREAS**, the City was unable to sell the said vehicle, due to lack of a free and clear title; and

**WHEREAS**, the City now has obtained a free and clear tile to the said vehicle, which an individual buyer, Christopher Bell, Chief of Capital City Protective Services of Hyattsville, MD 20785, is willing to purchase; and

**WHEREAS**, Mr. Christopher Bell is willing to pay \$900.00 for the Ford Crown Victoria; and

**WHEREAS**, it is in the public interest to authorize the sale of the said vehicle to Mr. Bell for \$900.00.

**NOW, THEREFORE BE IT RESOLVED; by the City Council of Glenarden, sitting in Regular Session this 8<sup>th</sup> day of September 2014, as follows:**

1. The sale of the 2000 Ford Crown Victoria (White) Vehicle Number 1FAP52U1WA159279 to Mr. Christopher Bell for the sum of \$900.00 be and it is hereby approved.
2. That all revenues collected from the sale of the said vehicle shall be deposited into the General Fund.
3. This resolution shall take effect immediately following the approval by Council.
