**WHEREAS**, there is a vacancy in the office of City Manager; and

**WHEREAS**, the Mayor has contacted Robert Half International, Inc., to provide personnel on a temporary basis to perform certain duties of the City Manager until such time as the position is filled pursuant to Section 501 of the Charter or until December 7, 2014, whichever first occurs; and

**WHEREAS**, the Council has determined that it is appropriate to authorize Robert Half International, Inc., to provide personnel on a temporary basis to perform certain duties of the City Manager on behalf of the City; and

**WHEREAS**, the Council has determined to appoint Kenneth M. Jones, Jr., of Robert Half International, Inc. effective September 8, 2014, to act as temporary City Manager until such time as the City Manager position is filled pursuant to Section 501 of the Charter or until December 7, 2014, whichever first occurs.

**NOW, THEREFORE, BE IT RESOLVED, by the City Council of Glenarden, sitting in Regular Session this 14th day of October, 2014, as follows:**

1. That Robert Half International, Inc., be and it is hereby authorized to provide personnel on a temporary basis to perform certain duties of the City Manager for the City of Glenarden, until such time as the position is filled pursuant to Section 801 of the Charter or until December 7, 2014, whichever first occurs.

2. That Kenneth M. Jones, Jr., be and he is hereby appointed, effective September 8, 2014, as the Temporary City Manager and is authorized to undertake all those powers and duties as set out in Section 503 of the Charter.
