12 **A Resolution Appointing Victoria Person to the Ethics Commission**

14 WHEREAS, according to Glenarden Code there may be a City of Glenarden Ethics
15 Commission, which shall be composed of three (3) members appointed by the Mayor and
16 approved by the City Council; and
17

18 WHEREAS, the Mayor has appointed **Victoria Person** to the Ethics Commission; and
19

20 WHEREAS, the Commission will serve to make a more effective and efficient form of
21 City Government;
22

23 WHEREAS, the Commission is a public body and must comply with the Maryland Open
24 Meetings Act; and
25

26 WHEREAS, the Commission shall be advised by the City Attorney and shall have
27 responsibilities including but not limited to the following:
28

29 (1) Devise, receive and maintain all forms required by Chapter 16, "Ethics" of the City
30 Code;
31

32 (2) Develop procedures and policies for advisory opinion requests and provide published
33 advisory opinions to persons subject to this chapter regarding the applicability of the provisions
34 of ethics code to them;
35

36 (3) Develop procedures and policies for the processing of complaints and to make
37 appropriate determinations regarding complaints filed by any person alleging violations of the
38 ethics code; and

40 (4) Conduct a public information program regarding the purposes and application of the
41 ethics code.

43 (5) Determine if changes to the ethics code are required to be in compliance with the
44 requirements of State Government Article, Title 15, Subtitle 8, Annotated Code of Maryland,
45 and shall forward any recommended changes and amendments to the City Council for enactment.

5 (6) Adopt other policies and procedures to assist in the implementation of the Commission's
6 programs established in Chapter 16 of the Code.

8 **NOW, THEREFORE BE IT RESOLVED** by the Mayor and City Council of the City of
9 Glenarden, Maryland, sitting in **Regular Session this 14th day of September 2015** as follows:

11 1. **Victoria Person** (Ward 2) be and she is hereby approved as an appointment to the
12 City of Glenarden Ethics Commission.

14 2. The term of office shall be two (2) years beginning September 14, 2015 through
15 September 11, 2017.
