13 **A Resolution Appointing Derryck Wilson to the Ethics Commission**  
14

15 **WHEREAS**, according to Glenarden Code there may be a City of Glenarden Ethics  
16 Commission, which shall be composed of three (3) members appointed by the Mayor and  
17 approved by the City Council; and  
18

19 **WHEREAS**, the Mayor has appointed **Derryck Wilson** to the Ethics Commission; and  
20

21 **WHEREAS**, the Commission will serve to make a more effective and efficient form of  
22 City Government;  
23

24 **WHEREAS**, the Commission is a public body and must comply with the Maryland Open  
25 Meetings Act; and  
26

27 **WHEREAS**, the Commission shall be advised by the City Attorney and shall have  
28 responsibilities including but not limited to the following:  
29

30 (1) Devise, receive and maintain all forms required by Chapter 16, "Ethics" of the City  
31 Code;  
32

33 (2) Develop procedures and policies for advisory opinion requests and provide published  
34 advisory opinions to persons subject to this chapter regarding the applicability of the provisions  
35 of ethics code to them;  
36

37 (3) Develop procedures and policies for the processing of complaints and to make  
38 appropriate determinations regarding complaints filed by any person alleging violations of the  
39 ethics code; and

41 (4) Conduct a public information program regarding the purposes and application of the  
42 ethics code.

3 (5) Determine if changes to the ethics code are required to be in compliance with the  
4 requirements of State Government Article, Title 15, Subtitle 8, Annotated Code of Maryland,  
5 and shall forward any recommended changes and amendments to the City Council for enactment.  
6

7 (6) Adopt other policies and procedures to assist in the implementation of the Commission's  
8 programs established in Chapter 16 of the Code.  
9

10 **NOW, THEREFORE BE IT RESOLVED** by the Mayor and City Council of the City of  
11 Glenarden, Maryland, sitting in **Regular Session this 14th day of September 2015** as follows:  
12

- 13 1. **Derryck Wilson** (Ward 3) be and he is hereby approved as an appointment to the  
14 City of Glenarden Ethics Commission.  
15
- 16 2. The term of office shall be two (2) years beginning September 14, 2015 through  
17 September 11, 2017.  
18

19 This Resolution shall take effect immediately following approval by the Council.


