Resolution Ratifying the Purchase of a Lawn Mower from Atlantic Tractor, L.L.C.

WHEREAS, the City of Glenarden, Maryland (“the City”) is responsible for the maintenance and upkeep of certain public spaces and rights-of-way; and

WHEREAS, the City’s maintenance and upkeep responsibilities include, among other things, mowing grass and weeds in said spaces, which activities are particularly necessary during the summer months; and

WHEREAS, the City’s Public Works Department requires a lawn mower to accomplish these activities and the City’s lawn mower, which had passed its generally-anticipated useful life, ceased operating in June 2015 and required repairs costing approximately \$2,500, which would, in the judgment of the City Council, have been an inefficient and unwise expenditure given the age of the equipment; and

WHEREAS, given the necessity of performing mowing activities frequently in the summer months, it would have been impractical to delay the acquisition of a new lawn mower for a period of time sufficient to perform a competitive bidding process and constitutes an emergency sufficient to justify an exception, under Section 826 of the City Charter, to the competitive bidding requirements set forth in Section 818 of the City Charter; and

WHEREAS, the City received proposals for the work from Gateway Tractor, Kohler Equipment, and Atlantic Tractor for a lawn mower of suitable quality and capacity to perform the City’s mowing functions; and

WHEREAS, Gateway Tractor and Kohler Equipment proposed to submit smaller lawn mowers at higher prices than the proposal of Atlantic Tractor; and

WHEREAS, the proposal of Atlantic Tractor, in the amount of Four Thousand Six Hundred Sixty-Four and 00/100 Dollars (\$4,664.00) for a 54” Titan Model No. ZX 5400 lawn mower by the Toro Company was the lowest and the most responsible of the proposals submitted; and

WHEREAS, the City Manager purchased the aforementioned Titan lawn mower on or about

1 September 1, 2015 in order to permit the City's Public Works department to perform urgently-
2 needed mowing of public rights-of-way and other spaces.

8 Company from Atlantic Tractor, L.L.C. for a purchase price of Four Thousand Six Hundred
9 Sixty-Four and 00/100 Dollars (\$4,664.00) by the City Manager be and hereby is ratified; and

11 2. That the payment of the contract amount from the General Fund be and hereby is ratified;




