WHEREAS, the Council is required to approve permits for construction in the M-X-T zone at the Woodmore Towne Centre at Glenarden site; and

WHEREAS, Petrie/ELG Inglewood, LLC submitted an application for a building permit, application # 2015-096, to the City of Glenarden for Fabulocs Natural Hair tenant fit out of 9100 McHugh Drive, Glenarden, MD 20706; and

WHEREAS, Prince George's County has reviewed and approved building permit application #36181-2015 for the tenant fit out of 9100 McHugh Drive, Glenarden, MD 20706; and

WHEREAS, the City of Glenarden Permit Review Committee has reviewed building application # 2015-096, for Fabulocs Natural Hair tenant fit out, as reflected in the attached committee report dated October 29, 2015, and finds it to be in conformance with the City of Glenarden Code, Chapter 52: Building Construction; and

WHEREAS, the Council has determined that the Building Permit for the Fabulocs Natural Hair tenant fit out should be issued.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of Glenarden, Maryland sitting in Regular Session this 14th day of December, 2015 as follows:

1. That Building Permit Application #2015-096 be granted and that a permit to construct the Fabulocs Natural Hair tenant fit out of 9100 McHugh Drive, Glenarden, MD 20706, as per the plans presented to the Council, be issued subject to:


40 A. Payment of the application fee (\$75.00) and building permit fee (\$1,275) for 9100


44 B. Submittal of three (3) copies of the approved Prince George's County Permit,





Action: Comments by Dianne Thomas relative to response to the committee concerns about the responsibility Section D of the Committee responsibility.


The Chairman will seek clarification from the Administration.
