A Resolution to Authorize Mayor Smith to Provide Personnel on a Temporary Basis to Perform Certain Duties of the City Manager and to Authorize Eddie Tobias to Act as the Temporary City Manager

WHEREAS, the current City Manager, Ken Jones, Jr. is on extended leave and unable to perform the City Manager duties; and

WHEREAS, the Mayor has contacted the International City Manager Association, (ICMA) to offer personnel on a temporary basis to perform certain duties of the City Manager until such time as the current City Manager is able to return to work; and

WHEREAS, the Council has determined that it is appropriate to authorize Mayor Smith, to provide personnel on a temporary basis to perform certain duties of the City Manager on behalf of the City; and

WHEREAS, the Council has determined to appoint Eddie Tobias, from the International City Manager Association effective January 11, 2016, to act as temporary City Manager until such time as the current City Manager is able to return to work.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of Glenarden, sitting in Regular Session this 11th day of January, 2016, as follows:

1. That Mayor Smith, be and it is hereby authorized to provide personnel on a temporary basis to perform certain duties of the City Manager for the City of Glenarden, until the current City Manager is able to return to work.
2. That Eddie Tobias, be and he is hereby appointed, effective January 11, 2016, as the Temporary City Manager and is authorized to undertake all those powers and duties as set out in Section 503 of the Charter.
