**Resolution to Approve Appointment of Captain Regis Bryant as the Chief of Police
for the City of Glenarden, Maryland**

WHEREAS, pursuant to Section 901 “Authority to employ Personnel “of the City of Glenarden’s Charter, The Chief of Police, as head of the police department, shall be appointed by the Mayor with the approval of the Council; and

WHEREAS, based upon the judgement, experience, and recommendations of two career officers and a former Deputy Attorney General of the State of Maryland who did conduct interviews on the 26th of October and determined Captain Regis Bryant the candidate most ready to assume the role, and

WHEREAS, the City Council wishes to appoint Captain Regis Bryant for the position of Chief of Police for the City of Glenarden, at the annual salary \$95,930.00, with said appointment to be effective upon approval of this resolution by the City Council; and

WHEREAS, the City Council has determined that it is appropriate to approve the appointment of Captain Regis Bryant as Chief of Police for the City of Glenarden; and

NOW, THEREFORE, BE IT RESOLVED, by the City Council of Glenarden, sitting in Regular Meeting this **11th day of April, 2022** as follows:

1. That the appointment of Captain Regis Bryant as Chief of Police for the City of Glenarden, at the annual salary of \$95,930.00, be and it is hereby approved pursuant upon a satisfactory background check, six-month probationary period, and the requirement to be commissioned and certified as a Police Officer in the State of Maryland.
2. That the Chief of Police is authorized to undertake all those powers and duties as set out in the Constitution of the State of Maryland, the Constitution
