**A RESOLUTION TO ADOPT AND ALLOCATE FUNDS FOR AN OUTDOOR  
FITNESS COURT AS PART OF THE 2022 NATIONAL FITNESS CAMPAIGN**

**WHEREAS**, the City of Glenarden has submitted a Grant Application to National Fitness Campaign (NFC) for participation in their 2022 initiative to install and activate outdoor Fitness Courts® in 200 cities and schools across the country, and;

**WHEREAS**, the City of Glenarden will accept a \$30,000 National Grant from our NFC Grant Committee and Statewide Partners, and provide a local match in the amount of One Hundred Twelve Thousand Three Hundred and Fifty Dollars (\$112,350) to promote and implement a free-to-the-public outdoor Fitness Court®, and;

**WHEREAS**, the City of Glenarden will secure supplemental funding as needed through community sponsors, which will be made available and committed to this program for the purchase of the outdoor Fitness Court®, and;

**WHEREAS**, the City of Glenarden will commit to construction and launch of the outdoor Fitness Court® by the end of the 2022 calendar year, and;

**WHEREAS**, the City of Glenarden believes the outdoor Fitness Court® is an important wellness ecosystem that supports healthier communities, commits to funding/fundraising to participate in NFC's 2022 Campaign, and will earn local and national recognition as a leader in providing affordable health and wellness.

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of Glenarden, Maryland sitting in **Regular Session this 13<sup>th</sup> day of June 2022** as follows:

1. That the source of funds is 20.38.10.4370 American Rescue Plan Act.
2. That this Resolution shall take effect immediately upon passage.
