**A Resolution to Declare City Property as Surplus and Approve Auction or Disposal of the Property**

**WHEREAS**, the City’s property has exceeded its useful life; and

**WHEREAS**, pursuant to Section 828 of the City Charter, the Mayor, with consent of the Council, may declare any unusable, obsolete, or outmoded personal property or equipment belonging to the City as surplus property; and

**WHEREAS**, these items can be declared as surplus property and sold to the general public or dispose as such.

**NOW, THEREFORE, BE IT RESOLVED**, by the Council of the City of Glenarden, sitting in Regular Session this **9th day of May 2022** has determined that:

1. The Administration has declared the attached list of items as surplus property which can be sold/dispose to the general public to the highest bidder or offeror.
2. The notice of sale of surplus property shall be made through a periodic surplus list placed in the Municipal Center and by circulation throughout the City with the monthly City Meeting notice.
3. The sale notice shall identify the means of acquisition to be by sealed bid, informal offer on auction date.
4. All revenues collected from the sale of surplus property shall be deposited with the Treasurer.
5. All surplus items which are to be sold, are to be sold “as is” and no guarantee or warranty of any kind is provided.
6. This Resolution shall take effect immediately upon passage.
