Excess stormwater runoff can also flood local communities, scour sediment from waterways, and degrade the health of stream systems; and

32 33 34 35 36 37 38	(1) The City of Glenarden will establish The Stormwater Best Management Practices (BMP) grant program to provide a rebate to property owners that install stormwater best management practices that help to enhance the water quality of the stormwater runoff and/or decrease the amount of stormwater runoff that enters the stormwater drainage system.				
39 40	(2) The total program grant will be \$200,000 funded by the American Rescue Plan Act monies.				
41 42 43	(3) With this program, the City will make a rebate reimbursement up to \$2,000 for any costs not reimbursed under other similar programs such as the Prince George's County Rain				

	Check Rebate Program, to the property owners who meet the requirements of the program.		
	(4) Work cannot proceed until the application as been pre-approved by the City.		
	(5) Applications will be received and approved on a rolling basis until September 30, 2022 or when the allocated grant funding has been exhausted, whichever comes first.		
	b) Reimbursement for approved work will be by direct payment to the property owner. The work must have been performed and completed between the dates of July 1, 2022 and June 30, 2023 to be eligible for the rebate program.		
	(7) Qualifying Work Eligible for Funding:		
	a. Bio-retention cells/Rain gardensb. Permeable pavementc. Rain barrels		
	d. Streambank stabilizatione. Soil quality restoration		
	(8) Stormwater best management practices (BMP) shall meet design criteria in the Maryland Stormwater Design Manual (Revised May 2009)		
	(9) Stormwater best management practices required of individual property owners for subdivisions and new developments are not eligible for rebate		
	(10) Stormwater best management practices for which the property owner seeks reimbursement from other sources of funding are not eligible for rebate		
	(11) After work is completed and by no later than August 31, 2023, additional documentation will be required including receipts or itemized contractor's invoice, proof of payment, and project photos.		
	(12) This Resolution shall take effect immediately following approval by the Council.
