**WHEREAS**, the City Council wishes to appoint Dean Stewart to the position of Treasurer for the City of Glenarden, at the annual salary indicated in the budget, said appointment to be effective upon approval of the Council; and

**WHEREAS**, the Council has determined that it is appropriate to approve the appointment of Mr. Dean Stewart as Treasurer for the City; and

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of Glenarden, sitting in Special Regular Meeting this **18<sup>th</sup> day of January, 2022** as follows:

1. That the appointment of Dean Stewart as Treasurer for the City of Glenarden, at the annual salary indicated in the budget, be and it is hereby approved pursuant to the authority granted in Section 801 of the Charter.
2. That the Treasurer is authorized to undertake all those powers and duties as set out in Section 802 of the City Charter.
4. That this resolution shall take effect immediately upon signature of the City Council.
