**Resolution to Approve Appointment of Charles L. Simpson, Jr. as the Director of
Public Works for the City of Glenarden, Maryland**

WHEREAS, pursuant to Section 901 “Authority to employ Personnel “of the City of
Glenarden’s Charter, the Director of Public Works, as head of the Public Works Department,
shall be appointed by the City Manager with the approval of the Council; and

WHEREAS, based upon the judgement, experience, and recommendations of the City
Manager and City Treasurer who did conduct interviews on the 28th of July and determined
Charles L. Simpson, Jr. to be the candidate most qualified to assume the role, and

WHEREAS, the City Manager recommends Charles L. Simpson, Jr. for the position of
Director of Public Works for the City of Glenarden, at the annual salary indicated in the budget,
with said appointment to be effective upon approval of this resolution by the City Council; and

WHEREAS, based on the resume attached hereto as Exhibit A, questions asked of
candidates - Exhibit B, City of Glenarden job announcement- Exhibit C, the City Manager has
determined, that it is appropriate to approve the appointment of Charles L. Simpson, Jr. as
Director of Public Works for the City of Glenarden; and

NOW, THEREFORE, BE IT RESOLVED, by the City Council of Glenarden, sitting in
Regular Session this 19th day of September 2022 as follows:

1. That the appointment of Charles L. Simpson, Jr. as Director of Public Works
for the City of Glenarden, at the annual salary indicated in the budget, be and it is
hereby approved pursuant to the authority granted in Section 901 of the City of
Glenarden’s Charter.
2. That this resolution shall take effect immediately upon approval by the
Glenarden City Council.
