- **R. Jones** – What opportunities have the administration put together for GS Proctor & Associates to do?

- **E. Fareed** – Agrees with Councilwoman Jones that the last request from the council to the administration was to formulate a plan on how we would use the consultant which we did not receive, so Councilwoman Fareed has concerns as well.

- **J. Herring** – The legislative session for the State of Maryland is almost over and only runs from January – March. We should suggest a shorter contract from 6-8 months. Conversations need to be had about what they are going to after the legislative session is over.
- **K. Guillaume** – What would be the purpose of voting on this resolution right now if the council has not been able to discuss the scope of work? Also, it would not be wise to vote on this legislation and start paying them 2k a month in service fees with no active projects.
- **R. Jones** – Suggest having a presentation from GS Proctor.
- **E. Fareed** – Councilwoman Erika L. Fareed made a motion to table this piece of legislation until we have more discussion to make sure we are spending the money properly.
- **President Curtis** – President Curtis requests the administration draft a statement of work and a short-term contract service from Sep – March to be reviewed by the council for GS Proctor.
