- **R. Jones** – Before Councilwoman Jones’ vote, she asked to have it go on record to state the following:

To the citizens of The City of Glenarden, the council wishes they could disclose what is being seen as a council to ensure that the citizens would trust the City Council in this matter. If all the council is for this resolution, Councilwoman Jones is asking the citizens to please trust the council in this matter because there are some things that cannot be discussed regarding personnel! Also, unlike the Pentagon, Fort Mead, or Andrews Airforce Base; 8600 Glenarden Parkway is not a Military installation we are Stateside.

We are civilians and expect the staff and citizens of the City of Glenarden to be treated as such, not as Military personnel.

- **Vice President Ferguson** – In November 2020 Vice President Ferguson was one of the councilmembers who voted for that change in power. However, at that time she did not have a clear understanding on how that change would impact the staff, but now is correcting her error.
