WHEREAS, the City of Glenarden established the Glenarden Housing Authority through adoption of Articles of Organization in Resolution No. 8-64, April 7, 1964 which authorized the execution of a cooperative agreement between the Glenarden Housing Authority (GHA) and the Town of Glenarden, thereafter known as the City of Glenarden and

WHEREAS, the City of Glenarden and the Glenarden Housing Authority entered into a Cooperative Agreement on April 13, 1964, which agreement has been amended from time to time and continues in effect; and

WHEREAS, Arlene Boateng tendered her resignation to the Glenarden Housing Authority; and

WHEREAS, the Mayor is authorized to appoint Commissioners to the Housing Authority, with approval of the City Council; and

WHEREAS, the Mayor has appointed **Kathleen Guillaume Delemar** to the Housing Authority Commission; and

WHEREAS, The Council has determined that the appointment of **Kathleen Guillaume Delemar** to the Housing Authority Commission should be approved.

NOW, THEREFORE BE IT RESOLVED by the Council of The City of Glenarden, sitting in regular session this 10th day of October 2017 has determined that:

1. **Kathleen Guillaume Delemar** be approved to fill the unexpired term of Arlene Boateng to the Glenarden Housing Authority Commission.
2. This term will expire on May 8, 2021.
