**Emergency Ordinance to Set the Real Property Tax Rate and Personal Property Tax Rate for Fiscal Year 2020**

WHEREAS, the Glenarden City Council proposes to set the real property tax rate for fiscal year 2020 at \$0.3579 per \$100 assessed value; and

WHEREAS, setting the tax rate at this amount would maintain the same rate as for FY 2019; and

WHEREAS, the City has been exempted from the requirements of §6-308 of the Tax-Property Article, Annotated Code of Maryland, with respect to the constant yield tax rate; and

WHEREAS, the Mayor and Council have determined that it is appropriate to set the tax rate for fiscal year 2020 at \$0.3579 per \$100 assessed value; and

WHEREAS, the City is authorized by §6-303 of the Tax Property Article, Annotated Code of Maryland, to set a personal property tax rate; and

WHEREAS, the current personal property tax rate is \$.83 per \$100 assessed value; and

WHEREAS, the Mayor and City Council propose to set the personal property tax rate for fiscal year 2020 at \$0.83 per \$100 assessed value; and

WHEREAS, the Mayor and Council have determined that the need for immediate adoption of the real property tax rate and notification of the tax rate to Prince George's County constitutes an emergency for purposes of adoption and the effective date of this ordinance.

**NOW, THEREFORE BE IT RESOLVED** by the Council of the City of Glenarden, Maryland, sitting in regular session this 10<sup>th</sup> day of June 2019:

1. That the real property tax rate for fiscal year 2020 for the City of Glenarden be and it is hereby set at \$0.3579 per \$100 assessed value.
2. That the personal property tax rate for fiscal year 2020 for the City of Glenarden be and it is hereby set at \$.83 per \$100 assessed value.
