17 **An Ordinance Enacting Chapter 14 "Elections", §14-1 "Candidate Petition Filing Fee" to**
18 **Require That Candidates for the Offices of Mayor and Councilmember Pay a Petition Filing**

21 **WHEREAS**, Section 705 of the City Charter authorizes the Council to set a fee to be paid
22 to the Board of Elections upon the filing of a petition for candidacy for the offices of Mayor or
23 Councilmember; and

25 **WHEREAS**, the Council has determined to set a fee of Twenty-five Dollars (\$25.00) as
26 the filing fee for Mayor and for each Councilmember.

28 **Section 1. NOW, THEREFORE BE IT RESOLVED AND ORDAINED**, by the Mayor
29 and City Council of Glenarden, Maryland that Chapter 14 "Elections", §14-1 "Candidate Petition
30 Filing Fee" be and it is hereby enacted as follows:

32 **CHAPTER 14 ELECTIONS**

33 **§14-1 CANDIDATE PETITION FILING FEE.**

34 **A CANDIDATE FOR THE OFFICE OF MAYOR OR COUNCILMEMBER, UPON THE**
35 **FILING OF A CANDIDACY PETITION AS REQUIRED BY SECTION 705 OF THE CITY**
36 **CHARTER, SHALL PAY A FEE IN THE AMOUNT OF TWENTY FIVE DOLLARS (\$25.00)**
37 **TO THE BOARD OF ELECTIONS.**

38 **Section 2. BE IT FURTHER ORDAINED**, by the City Council of Glenarden, Maryland
39 that this ordinance shall become effective twenty days following approval by the Mayor or passage
40 by the Council over the Mayor's veto.






