A Resolution to Authorize Purchase Toughbooks for the Police Department

WHEREAS, the Council has determined that it is in the public interest to authorize the Glenarden Police Department to purchase Toughbooks and related items for use by its police officers to increase the public health and safety; and

WHEREAS, the Council has previously approved in the budget the purchase of equipment to outfit its police officers; and

WHEREAS, it is necessary to purchase four (4) Panasonic Toughbooks, Standard, Win 10 Pro, Intel Core i5-7300U and accessories for the total sum of \$15,408.00 to properly outfit a Glenarden Police officer; and

WHEREAS, the four (4) Panasonic Toughbooks with the proper specifications can be purchased from Global Public Safety, Inc., under a competitively bid contract with Prince George's County; and

WHEREAS, the purchase is authorized without a formal bid process pursuant to Section 818(b) of the City Charter.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of Glenarden, Maryland sitting in Regular Session this 8th day of February 2021 as follows:

1. That the purchase from Global Public Safety, LLC., of four (4) Standard, Win 10 Pro, Intel Core i5-7300U, Toughbooks and accessories for a total amount of \$15,408.00, per the proposal attached as Exhibit A to this resolution, be and it is hereby approved; and
2. Payment for the police Toughbooks and accessories shall be made from the Capital Project Outlay - Support Equipment line-item number 8360-10-55-50 in the budget.
3. This Resolution shall take effect immediately upon passage.
